**A BYLAW OF THE TOWN OF ST. WALBURG RESPECTING
THE SIGNING CORRIDOR, HIGHWAY #26, NORTH AND SOUTH OF THE TOWN LIMITS
LOCATED WITHIN THE R.M. OF FRENCHMAN BUTTE #501**

The *Council* of the Town of St. Walburg in the Province of Saskatchewan enacts as follows:

SHORT TITLE

1. This Bylaw may be known and cited as the "Signing Corridor Bylaw."


PURPOSE

2. The purpose of this bylaw is to regulate and control the design and location of signs erected in the signing corridor to the north and south of the Town of St. Walburg.

DEFINITIONS

3. In this bylaw:
 - a. "Act" means *The Highways and Transportation Act, 1997, The Municipalities Act and The Provincial Highway Sign Control Regulations* and amendments thereto;
 - b. "Administrator" means the Chief Administrative Officer (CAO) of the Town of St. Walburg;
 - c. "Advertising Device" means a device, other than a type of sign that is placed or affixed, within the signing corridor and that advertises, attracts attention to or promotes publicly for an individual, business, organization, product, or event and includes banners, bunting, streamers, strings of flags or multiple flag installations, lights, balloons, dirigibles, holograms and search lights and other devices that are decorative in nature:
 - i. on land; or
 - ii. on or to any object, structure, or other thing that is on or affixed to land;
 - d. "Advertising Sign" means any sign intended to promote the sale of a specific product or the use or patronage of a specific business or activity;
 - e. "Agriculture Enterprise" means any activity that:
 - i. derives produce directly from the work of cultivating the soil, or the raising of livestock or poultry, and which provides the primary source of income to the person owning or operating the enterprise; or
 - ii. is associated with the primary processing of agriculture products;
 - f. "Agricultural Research or Demonstration sign" means a sign related to research or demonstration of agricultural products or activities;
 - g. "Auction sign" means a temporary sign displaying only:
 - i. the name of the auctioneer; and
 - ii. details of the sale;
 - h. "Commercial Area" means an area outside the municipality which is subdivided to allow three or more business lots;
 - i. "Community promotional sign" means a sign that is erected by or on behalf of a municipality and that contains information about the municipality;
 - j. "Council" means the Council of the Town of St. Walburg;
 - k. "Designated Officer" means an employee or agent of the Municipality appointed by Council to act as a municipal inspector for the purposes of this Bylaw;
 - l. "Election Sign" means a sign erected by or on the authority of a candidate in an election held pursuant to the *Canada Elections Act, The Election Act, 1996 or The Local Government Election Act*;
 - m. "Identification Sign" means a sign that displays any or all, of the following, with respect to land:
 - i. the name of the owner or occupier of land, or the business or activity carried out on the land;
 - ii. the type of business or activity carried out on the land;
 - iii. direction and distance from the public highway to the business or activity carried out on the land;
 - iv. the logo, slogan, or telephone number of the business or activity carried out on the land; or
 - v. an advertisement respecting the goods or services provided by the business or the activity,

but only if the sign is on the same land as that on which the business or activity is being carried on;

- n. "Logo" means a non-heraldic symbol used to identify a business or organization;
- o. "Municipal Highway" means a public highway under the control and administration of a municipality;
- p. "Municipality" means the Town of St. Walburg;
- q. "Off-premise Sign" means a sign that is located separate and apart from the land on which the business or activity is located;
- r. "On-premise Sign" means a sign that is located on the land on which the business or activity is located;
- s. "Permit" means a valid and subsisting permit issued pursuant to subsection 29(3) of *The Highways and Transportation Act, 1997* and this bylaw;
- t. "Private Sign" means an on-premise or off-premise sign owned by a person or business;
- u. "Provincial Highway" means any public highway that the Department of Highways and Transportation maintains;
- v. "Right-of-Way" means the property owned by Her Majesty in the right of Saskatchewan for a public highway or a roadway;
- w. "Sight Triangle" means a triangular area, as determined by the minister, at an intersection of a provincial highway with another public highway or railway crossing, that is to be kept clear of sight obstructions for persons approaching the intersection or crossing, formed by straight lines joining:
 - i. the point of centerline intersection of the provincial highway and the intersecting road or railway line;
 - ii. a point 230 meters from the point of centerline intersection, as measured along the highway centerline; and
 - iii. a point 80 meters from the point of centerline intersection, as measured along the centerline of the road or railway line;
- x. "Sign" means a written mark, free-standing structure or device that is not part of any building and that is used for the purpose of providing information or advertising to the public;
- y. "Sign Corridor" means a strip of land that is parallel and adjacent to the right of way of a provincial highway and for which the minister has issued a permit in accordance with Part IV of *The Provincial Highway Sign Control*, as a location for community promotional off-premise signs or identification signs; and
- z. "Sign Corridor Administrator" means the Chief Administrative Officer for the Town of St. Walburg.

REGULATIONS

- 4. The Council, subject to subsection (a) and (b), may authorize the Administrator of the municipality or any other person to perform any duties and to exercise any powers, as provided for by this bylaw, impose on them by Council and the performance of those duties and the exercise of these powers by the authorized person is deemed to be the performance or exercise, as the case may be, of the council.
 - a. The Council or its agent have the right to grant, refuse, suspend, or revoke the permit in its absolute discretion subject to the discretion being exercised in good faith without discrimination and in the public interest.
 - b. The Council or its agent need not give reasons for any refusal of a permit so long as the power is exercised in good faith without discrimination and in the public interest.

5. No person shall erect, place, or otherwise locate within the sign corridor, a private sign that:
- a. displays any intermittent, flashing, or rotating light (Flood lights, yard lights, area lighting or other lights that, in the opinion of the sign corridor administrator, are excessively distracting to the public or create a traffic hazard;
 - b. has any moving or rotating parts (Moveable message signs, moving or rotating parts, devices with flashing, blinking, or turning lights);
 - c. in any way resembles an official sign or a standard or a commonly used traffic control device and that may cause motorist confusion (any sign that bears a legend giving a command such as "stop", "stop ahead", "turn", "caution", etc. or any legend that in any way imitates a standard commonly used traffic control device, an official traffic sign or other traffic-regulating device. The colors of red and yellow will be prohibited as background colors);
 - d. is located within any sight triangle and, by itself, interferes with sight lines of any road intersection or at-grade railway crossing; or the area which a sight line covers (for one corner of an intersection) is triangular in shape and can be determined by measuring 230 meters along the centerline of the highway and 80 meters along the centerline of the intersecting roadway or railway crossing;
 - e. is greater than 0.30 square meters in area for every meter that it is distant from the highway centerline.
 - f. *The Alcohol Control Act* restricts any advertising or reference by sign or billboard promoting alcoholic beverages. This includes any references to beverage rooms, "Happy Hours", liquor or beer company sign sponsors, their logos or products.

PERMIT APPLICATIONS, TERMS, AND CONDITIONS

6. A person who wishes to erect an off-premise sign shall apply to the municipality on an application form, known as "Schedule A", to be provided by the municipality.
7. An applicant may apply pursuant to Section 6 to erect more than one off-premise sign.
8. Where the municipality receives an application pursuant to Section 6, the Administrator may:
- a. grant a permit to the applicant to erect an off-premise sign; or
 - b. refuse to grant a permit to the applicant.
9. A permit is deemed to be granted subject to the following terms and conditions
- a. the holder of a permit shall ensure that the sign is constructed and maintained as per guidelines outlined in "Appendix I" of this bylaw;
 - b. the holder of a permit shall ensure that all signs erected under the permit are located off the right-of-way and do not encroach on the right-of-way of a public highway;
 - c. the holder of a permit shall ensure that all signs erected under the permit are maintained in an appearance that is, in the opinion of the Administrator, neat and professional;

- d. the holder of a permit shall pay the annual fees, as per "Appendix II" associated with the sign;
 - e. no holder of a permit shall erect a sign under the permit, that may, in the opinion of the Administrator, cause or create an unacceptable hazard or distraction to a driver on a public highway; and
 - f. the holder of a permit shall ensure that all signs erected under the permit conform to all local municipal bylaws dealing with the erection and maintenance of signs.
10. No holder of a permit shall erect an off-premise sign pursuant to the authority of the permit:
- a. adjacent to any public highway, where official signs are in place on that public highway and those official signs contain guidance, direction, or information of the same kind that will be put on the off-premise sign;
 - b. the minimum distance between signs is twelve (12) meters for every square meter of area of the larger of the two signs, up to a minimum distance of one hundred and fifty (150) meters for signs larger than 12.5 square meters in area;
 - c. nearer than 500 meters from the intersection of two provincial highways, or a provincial highway and a provincial road and for the purposes of this clause and in the case of an interchange, the 500 meters is to be measured along the highway from the nearest end of the pavement widening at the exit from or entrance to the main travelled lanes;
 - d. that is greater than 23 square meters in area;
 - e. that is greater than eight (8) meters in height from the bottom of the sign support to the top of the sign face;
 - f. that is made to form part of or is attached to a fence or building;
 - g. that is installed on trees or painted or drawn on rocks or other natural features;
 - h. that is installed adjacent to a horizontal curve on any provincial highway where an advisory speed has been posted;
 - i. incorporates an advertising device as part of its make-up or structure; or
 - j. on land owned by Her Majesty in right of Canada or in right of Saskatchewan, unless it is set back from the centerline of the highway a distance as specified in the sign permit.

EXEMPTIONS FROM THE REQUIREMENT OF A FEE FOR A PERMIT

11. In the case of off-premise signs, no fees as indicated on "Appendix II", are required for the following:
- a. directional signs containing only the words "Auction Sale" or "Auction Sale Today" along with a directional arrow and the distance to the sale, where those signs:
 - i. are erected on the day of the sale and removed on the day after the sale; and
 - ii. the area of the sign does not exceed one square meter in area;
 - b. election signs up to three square meters in area, where:

- i. the election signs are not erected until after the election writ has been issued;
 - ii. in the case of municipal elections, signs are not erected more than thirty (30) days before the date of the election;
 - iii. removed within seven calendar days after the date of the election; and
 - iv. the sign is not erected on any shoulders, side slopes, ditches, back slopes, medians, roadways, or approaches to a provincial highway;
 - c. one industrial development sign per industrial development site for each direction of travel, but only if:
 - i. the sign does not exceed one square meter in area; and
 - ii. the sign indicates the location and identity of start-up operations for forestry, mining, oilfield exploration, or other similar activities, where those signs are removed after the completion of start-up operations;
 - d. utility company signs to indicate buried property of the utility or other signs required by statute;
 - e. one real estate open house sign per open house for each direction of travel, but only if:
 - i. the sign does not exceed one square meter in area; and
 - ii. the sign is erected no sooner than one day before the date of the open house and is removed on the day after the date of an open house;
 - f. one agricultural demonstration sign per demonstration site for each direction of travel, but only if:
 - i. the sign does not exceed one square meter in area;
 - ii. identifies research, demonstration, or promotional projects related to the agricultural activities of a non-profit organization; and
 - iii. the sign is erected no sooner than one day before the date of the demonstration and is removed on the day after the date of the demonstration;
 - g. wildlife management information signs.
12. The off-premise signs described in Section 11 may be erected up to one meter inside the edge of a public highway right-of-way but only where they:
- a. are not erected in the ditch or on the roadway or approaches to the public highway;
 - b. do not, in the opinion of the municipality, interfere or obstruct the view of official signs or the safe sight lines at intersections; and
 - c. do not constitute a hazard to traffic.

CANCELLATION OF PERMIT

13. The Administrator may cancel a permit granted to erect an off-premise sign at any time by giving the holder of the permit a written notice of the cancellation personally or by registered or certified mail addressed to the last known address of the holder of a permit that is known.
14. The Administrator shall give at minimum sixty (60) days' notice of cancellation, before proceeding to remove the off-premise sign.
15. The municipality will not refund any fees associated with the removal of an off-premise sign.

IDENTIFICATION SIGNS

16. An identification sign may be erected only by:
 - a. a non-profit organization for the purpose of advertising a one-time or annual event;
 - b. an agricultural or business enterprise whose premises are not located adjacent to a public highway, for the purpose of identifying the location of the premises and the nature of the business; or
 - c. a non-profit, religious, or community organization whose premises are inside the town and are not adjacent to a provincial highway, for the purpose of identifying the location of the premises.
17. A person who wishes to erect an identification sign shall:
 - a. apply to the municipality on an application form, known as "Schedule A", to be provided by the municipality;
18. An applicant may apply pursuant to Section 17 to erect more than one off-premise sign.
19. Where the municipality receives an application pursuant to Section 17, the Administrator may:
 - a. grant a permit to the applicant to erect an off-premise sign; or
 - b. refuse to grant a permit to the applicant.
20. A permit is deemed to be granted subject to the following terms and conditions, as identified in Section 9 of this bylaw.

ENFORCEMENT

21. The administration and enforcement of this bylaw is hereby delegated to the Administrator for the Municipality.
22. The Administrator of the Municipality is hereby authorized to further delegate the administration and enforcement of this bylaw to another designated officer of the Municipality.

INSPECTIONS

23. The inspection of property by the Municipality to determine if this Bylaw is being complied with is hereby authorized.

24. Inspections under this Bylaw shall be carried out in accordance with Section 362 of *The Municipalities Act*.
25. No person shall obstruct the Administrator who is authorized to conduct an inspection under this section, or a person who is assisting a Administrator.

ORDER TO REMEDY CONTRAVENTIONS

26. If the Administrator finds that a person is contravening this Bylaw, they may, by written order, require the permit holder, to which the contravention relates to remedy the contravention.
27. Orders given under this Bylaw shall comply with Section 364 of *The Municipalities Act*.
28. Orders given under Bylaw shall be served in accordance with Section 390(1)(a), (b) or (c) of *The Municipalities Act*.

REGISTRATION OF NOTICE OF ORDER

29. If an order is issued pursuant to Section 26, the Municipality may, in accordance with Section 364 of *The Municipalities Act*, give notice of the existence of the order by registering an interest against the title to the land that is the subject of the permit holder.

APPEAL OF ORDER TO REMEDY

30. A person may appeal an order made pursuant to Section 26 in accordance with Section 365 of *The Municipalities Act*.

MUNICIPALITY REMEDYING CONTRAVENTIONS

31. The Municipality may, in accordance with Section 366 of *The Municipalities Act*, take whatever actions or measures are necessary to remedy a contravention of this Bylaw.
32. In an emergency, the Municipality may take whatever actions or measures are necessary to eliminate the emergency in accordance with the provisions of Section 367 of *The Municipalities Act*.


RECOVERY OF UNPAID EXPENSES AND COSTS

33. Any unpaid expenses and costs incurred by the Municipality in remedying a contravention of this Bylaw may be recovered by civil action for debt in a court of competent jurisdiction in accordance with Section 368 of *The Municipalities Act*.

OFFENCES AND PENALTIES

34. No person shall:
- a. fail to comply with an order made pursuant to this Bylaw;
 - b. obstruct or interfere with the Administrator or any other person acting under the authority of this Bylaw; or
 - c. fail to comply with any other provision of this Bylaw.


35. A Designated Officer who has reason to believe that a person has contravened any provision of this Bylaw may serve on that person a Notice of Violation, which Notice of Violation shall indicate that the Municipality will accept voluntary payment in the sum of One Hundred Dollars (\$100.00) to be paid to the Municipality within thirty (30) days.
36. Where the Municipality receives voluntary payment of the amount prescribed under Section 32 within the time specified, the person receiving the Notice of Violation shall not be liable to prosecution for the alleged contravention.
37. Payment of any Notice of Violation does not exempt the person from enforcement of an order pursuant to section 26 of this bylaw.
38. Every person who contravenes any provision of the Nuisance Bylaw is guilty of an offence and liable on summary conviction:
- a. in the case of an individual, to a fine of not more than \$10,000;
 - b. in the case of a corporation, to a fine of not more than \$25,000; and
 - c. in the case of a continuing offence, to a maximum daily fine of not more than \$2,500 per day.

COMING INTO FORCE


39. This Bylaw shall come into force and take effect from and after the day of final passing thereof.
40. Bylaws 12-88 and 6-91 are hereby repealed in their entirety.

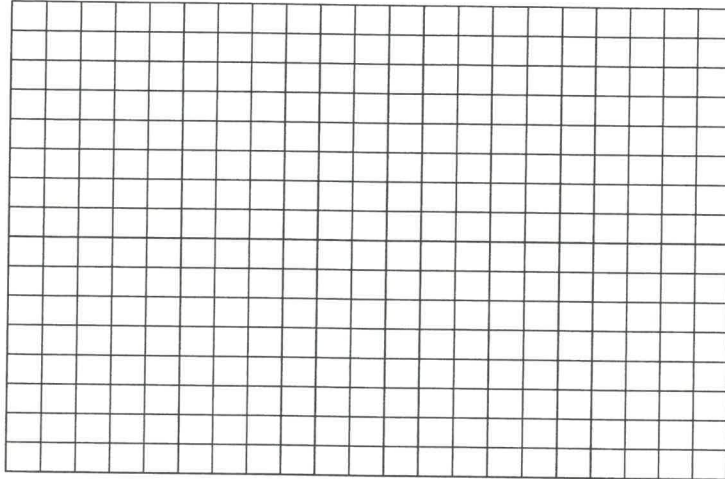

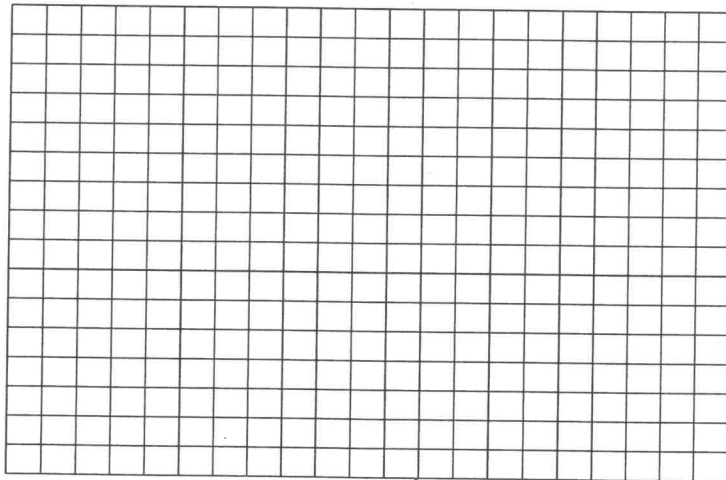

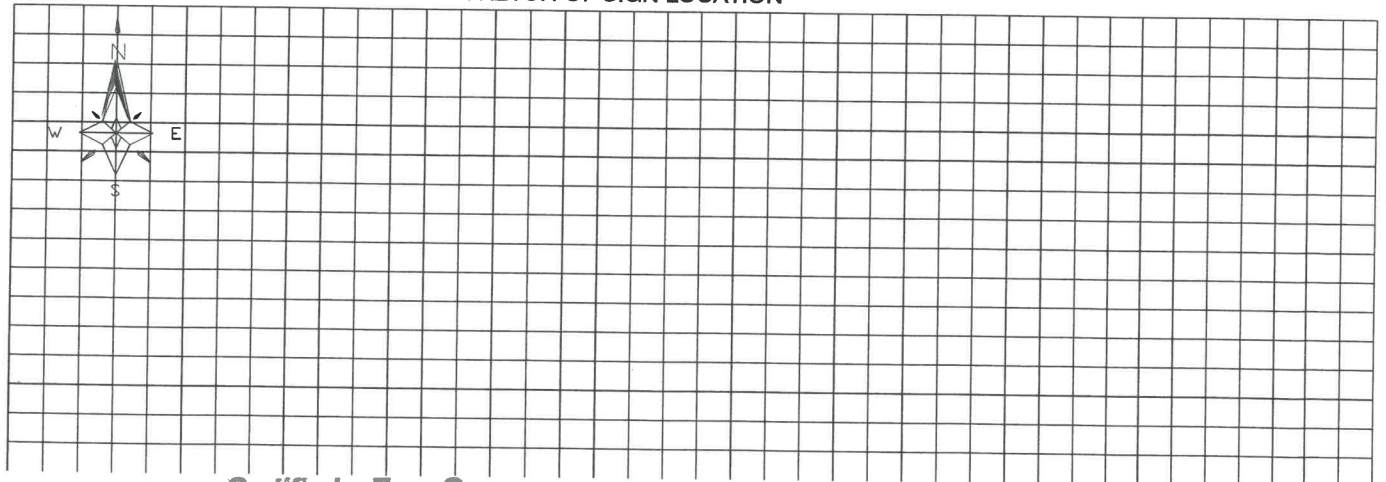

SIGN DESIGN GUIDELINES

Message Clarity	Three or four lines of information with three or four words per line is suggested.
Lettering	<p>Letters should be tightly compressed.</p> <p>Upper- and lower-case letters are acceptable and improves legibility.</p> <p>Script of highly stylized lettering types are difficult to read and should be avoided.</p> <p>Simple Gothic or Helvetica style block lettering is most commonly used.</p> <p>Minimum lettering size is fifteen centimeters (15 cm or 6").</p> <p>Most commonly used size is twenty to twenty-five centimeters (20-25 cm or 8-10").</p> <p>Size must remain consistent, whether it be upper and lower case, OR all upper case, OR all lower case.</p> <p>Varying size of lettering on different lines provides emphasis.</p>
Sign Specifications	<p>Use of symbols or symbolic signs is advantageous:</p> <ul style="list-style-type: none">- legibility distance is increased;- perception time is improved; and- illiterate or non-English speaking motorists can understand the message. <p>Signs may display:</p> <ul style="list-style-type: none">- the name of the owner or occupier of the enterprise or organization;- the type of enterprise or organization;- direction or distance information to the enterprise or organization; and/or- the logo, telephone number, hours of operation of the applicant and if the enterprise or organization is open or closed. <p>Advertising is not permitted on the off-premise or identification signs.</p>
Visibility	<p>Retro-reflective materials similar to highways signs, or electrical illumination which would light the sign internally or externally.</p> <p>Illumination must be designed to ensure that there is no glare or undue distraction. Running or flashing lights are strictly prohibited.</p>
Sign Material/Installation	<p>Sign must be covered both front and back with a neutral color.</p> <p>4"x4" posts of a length to ensure proper mounting of sign, placed firmly in ground to depth of at least one meter (1 m or 3') for a 4'x8' sign.</p> <p>Posts must be painted.</p> <p>Bottom of sign should be at least one meter (1 m or 3') from the ground.</p>

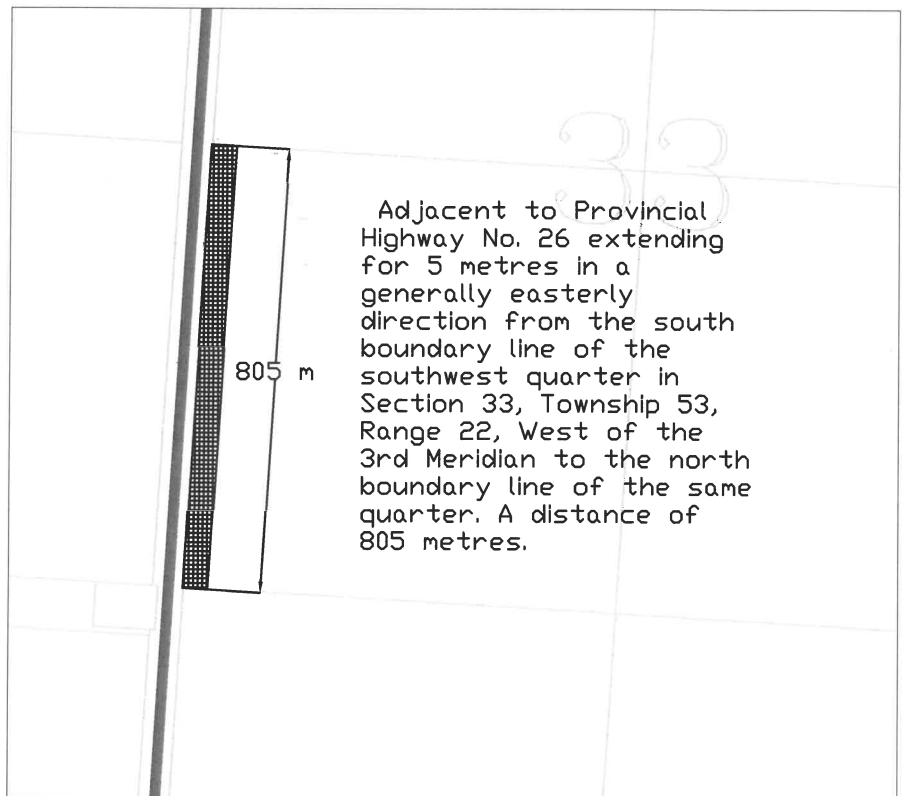
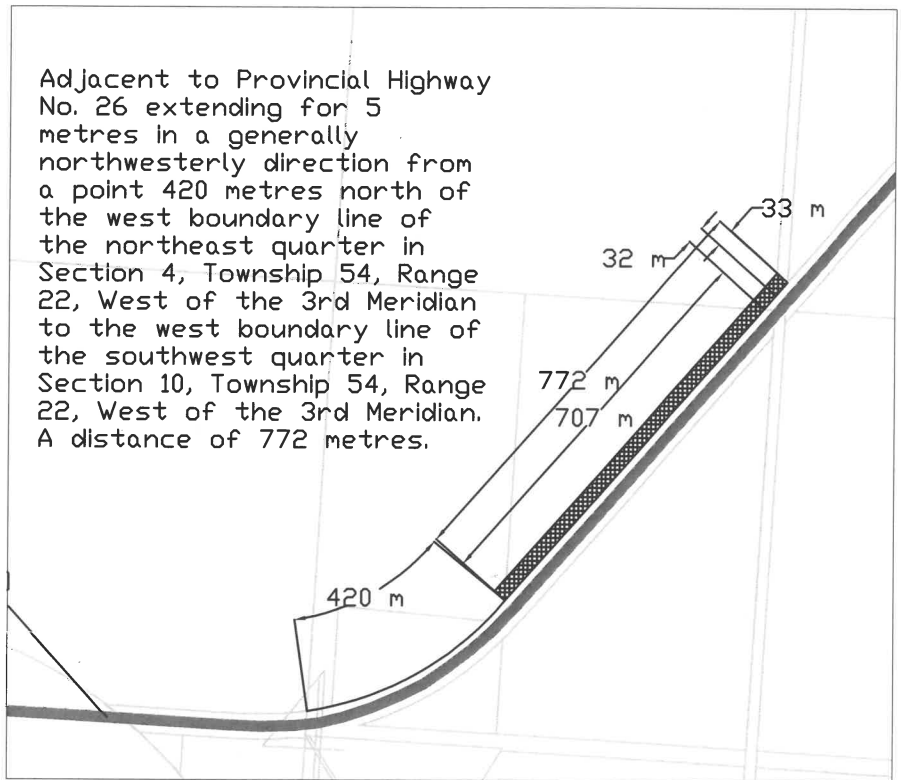
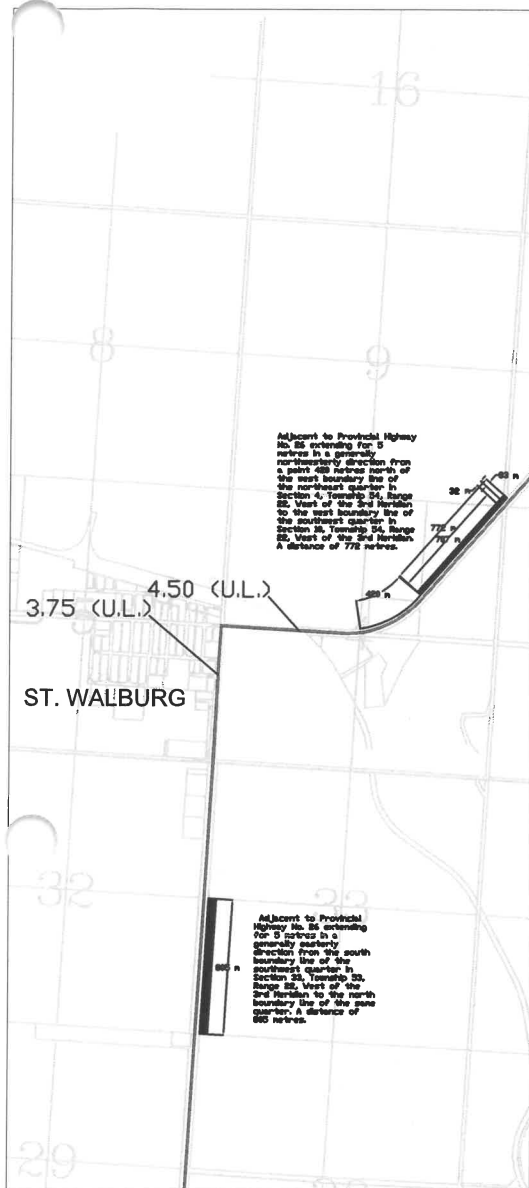
