Mayor's Message

A month ago few of us had ever heard of COVID-19, yet today it dominates our thoughts, it is changing our lives.

This viirus is the focus of Your Council and we are concerned about you—our ratepayers, our relatives, our co-workers, and our friends. We worry about your welfare and economic fall out.

We know that there are those that cannot drive. We know that there are people that don't wish to leave their homes, yet there are some people who need groceries, items from the pharmacy and they might wish takeout from one of our restaurant's.

To assist with the above, we offer a Delivery Service free of charge, within Town Limits. You simply need to call 306-248-3518 and make arrangements. Of course, you need to pay for your items but we can deliver them or pick you up in the Transit Bus. At this time, until April 30, 2020, there will be no charge for the Transit Bus. This deferral will be reviewed by Council on a monthly basis going forward, with respect to COVID-19.

As well we know that the virus has had an economic impact on the entire community. The Town has limited resources but Council has passed a resolution that enables administration to issue utility bills with charges only reflecting minimum. Any residential property bill will be \$61.78 and any commercial property will be \$86.78. Each bill will have an accurate reading with the consumption reduced to four (4) cubic meters. This reduction in utility bills will be reviewed monthly by Council.

In these difficult times, we need to help each other. Help your neighbor, make certain that they are ok and have their groceries and medications; while practicing Social Distancing. Please do not enter any residence except your own.

Be kind to each other—this too will pass.

What Can You Do?

Importance of Civic Address—Display

Your civic number is the main physical feature used by emergency responders when locating the source of a 9-1-1 call. Every owner of a residence or business in the Province must display their civic address number in a way that is clearly visible from the main roadway. This allows emergency responders to find the address quickly in an emergency situation. The Town would like to see all properties to have their Civic Address prominently displayed.

Up-To-Date Contact Information

The Town of St. Walburg is requesting that each resident update their contact information with the Town Office. The Town Office occasionally needs to contact residents to discuss important information such as snow removal, billing information, water breaks, etc. Without the proper information, ratepayers are left in the dark ~ by ensuring that the Town Office has the most current phone number, email address and mailing address will aid in the communication. Utility Billing for March 2020

Council has reviewed the utility billing process with respect to the current situation that is occurring. Town Council has requested administration to complete the monthly billing for March 2020 and provide each residential and commercial property with a minimum billing—based on four (4) cubic meters of usage. Each bill will have the most recent reading, however the consumption for the period will remain at maximum 4. This will mean that residential utility bills will be \$61.78 and commercial utility bills will be \$86.78. While COVID-19 is prevalent, Council will review on a month to month basis.

Social Distancing

Town Council is encouraging all members of our Community to practice Social Distancing. Avoid large crowds and do not shake hands, hug, etc. Social distancing involves avoiding interactions with people outside of those who live in your household.
