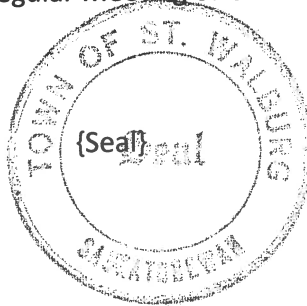
The COUNCIL of the ***Town of St. Walburg***, in the Province of Saskatchewan, enacts as follows:


1. That Appendix II – Application and Annual Fee Schedule of Bylaw 2019-14 be replaced in its entirety, as attached.

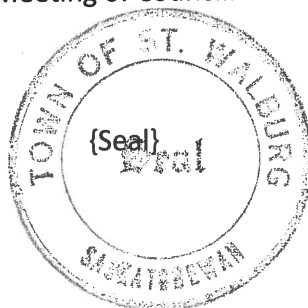
