  - c. "CAO" shall mean the person appointed as Chief Administrative Officer pursuant to Section 110 of The Municipalities Act.

## PARTNERSHIP AGREEMENT

- 3. The Town of St. Walburg is hereby authorized to enter into a Partnership Agreement to Establish a Joint Aerated Lagoon Project Management Committee with the R.M. of Frenchman Butte No. 501 and the Village of Paradise Hill.

The Village of Paradise Hill, a body corporate under the laws of the Province of Saskatchewan hereinafter called the "Village"

And

The Town of St. Walburg, a body corporate under the laws of the Province of Saskatchewan hereinafter called the "Town"

And

Rural Municipality of Frenchman Butte No. 501, a body corporate under the laws of the Province of Saskatchewan hereinafter called the "RM"

WHEREAS the Village, Town and the RM wish to construct a Regional Aerated Lagoon jointly, The Village, Town and the RM, hereinafter called the "partners", hereby agrees to the following:

- 1. A committee shall be established as follows:
  - a) Village of Paradise Hill 2 representatives
  - b) Town of St. Walburg 2 representatives
  - c) RM of Frenchman Butte No. 501 2 representatives

Hereinafter called the "committee"

- 2. Representatives are appointed by resolution passed by their respective councils.
- 3. One representative from each partner must be in attendance to hold a meeting.
- Each partner shall have one vote on the committee.
- 5. The committee shall appoint a chairperson and vice chairperson at their first meeting.
- A recording secretary shall be supplied by the Town of St. Walburg. The secretary will be responsible for arranging meetings, preparing an agenda in consultation with RM administrator and taking minutes of committee meetings.
- 7. The committee shall meet monthly or when requested to do so by the Project Engineer or any partner.

- 8. The committee shall have the authority to review tenders, contracts, billings, progress payments and out of scope work orders and approve recommendations to the RM of Frenchman Butte No. 501 to proceed with awarding of tenders, signing of contracts, and issuing of payments, etc.
- The committee has the authority to approve out of scope work orders to a maximum to \$25,000 and for work orders exceeding \$25,000 a resolution from respective councils is required.
- The committee will research and make recommendations to the partners on establishing a Utility Commission to operate the Joint Aerated Lagoon once construction has been completed.
- 11. The RM shall assume all the responsibility for the administration of project expenses, capital grant payment requests, easements, land acquisition, and any other duties arising from the construction of the project. Cost of project administration will be borne by the RM.
- 12. The RM shall include all revenue and expenses within their operating budget and financial records and it shall be audited as part of the RM of Frenchman Butte No. 501 yearend financial statements.
- 13. The partners hereby agree that all costs associated with project after March 1, 2017 that are NOT reimbursed by capital grants shall be invoiced to the partners at the following percentages:

a) Village of Paradise Hill -

31.582%

b) Town of St. Walburg —

35.085%

) RM of Frenchman Butte No. 501 -

33.333%

- 14. The RM shall invoice partners at the pro-rated rates shown in number 13 after each grant payment request has been submitted for expenses which qualify under the Building Canada Fund Grant.
- 15. The RM shall invoice partners at the pro-rated rates shown in number 13 monthly for costs that do not qualify for reimbursement under the Building Canada Fund Grant such as lease fees, land improvements, easements, etc.
- 16. The Town and Village shall pay all RM invoices within 30 days of receipt.
- 17. The RM shall supply the committee with a monthly financial statement of project costs to date on or before the 15<sup>th</sup> of the following month. It should be noted that monthly financial statement for December may be presented later as all invoices for yearend may not have been yet received.
