

TOWN OF ST. WALBURG
BYLAW NO. 7-2000

**A BYLAW OF THE TOWN OF ST. WALBURG, TO PROVIDE FOR A
 PERMANENT CLOSURE OF A LANE.**

WHEREAS Section 11 of the Highways and Transportation Act, 1997, provides for the closure of any road or walk-way vested in the Crown, subject to the consent of the Minister of Highways and Transportation, and following Public Notice of the proposed closure;

AND WHEREAS Section 156 of the Urban Municipality Act, provides that public streets and walk-ways are subject to the direction, control and management of the Municipality;

AND WHEREAS the Minister of Highways and Transportation has consented to and Council has given the required Public Notice of the proposed closure;

THEREFORE the Council for the Town of Walburg, in the Province of Saskatchewan, ENACTS:

- (1) TO permanently close all that portion of the land, Block 24, Registered Plan Number CA4130, St. Walburg, Saskatchewan, DESCRIBED AS FOLLOWS:**

"COMMENCING at the N.W. corner of Lot 8, Block 24; THENCE westerly to the N.E. corner of Municipal Reserve MR4; THENCE southerly along east boundary of said Municipal Reserve MR4, to the S.E. corner of said Municipal Reserve MR4; THENCE easterly to the S.W. corner of Lot 12, Block 24; THENCE northerly along the easterly boundary of said Lane to point-of-commencement."

- (2) THAT the Minister undertakes such other things to effect the intent of this Bylaw.**
