A BYLAW OF THE TOWN OF ST. WALBURG





To Fix the Rates to be Charged for the Use and Consumption of Water and Sewer

The Mayor and Council of the TOWN of ST. WALBURG in the Province of Saskatchewan enacts the following:

PART I: INTERPERTATION

1. The purpose of this Bylaw is to establish sewer and water rates in the Town of St. Walburg.

PART II: RESPONSIBILITY

- 2. Applications for connection of the Town of St. Walburg's systems for water and/or sewer shall be made to the Town Office. An application fee and/or meter deposit, as determined by Resolution of Council, shall be submitted with the application.
- 3. Rates for water services shall be those set out in Schedule 'A' (attached); there is a minimum monthly amount payable whether any water is consumed.
- 4. Rates for premises drained, or that by bylaw are required to be drained, into the sewer system shall be those set out in Schedule 'B' (attached); there is a minimum monthly amount payable whether any sewer is drained.
- 5. Accounts for water and/or sewer services shall cover a period of month and shall be billed on or before the first day of the month that follows such period. Accounts shall be paid within thirty [30] days from the date of billing.
- 6. A penalty of 2% will be added to water and/or sewer accounts outstanding at the date of the next billing.
- 7. Any account not paid within thirty [30] days from the date of billing may receive notice and be disconnected. The service(s) will be reconnected once arrangements for account payment are agreed upon.
- 8. A reconnection fee of \$75 during regular working hours or \$125 outside of regular working hours will be added to the account and payable upon reconnection.
- 9. The Town shall have the right to ration or limit the usage of water and/or sewer systems should circumstances warrant such action.

This Bylaw shall come into force and take effect upon the day of approval being issued by the Local Government Committee.

2023 MONTHLY WATER RATES:

4 cubic meters or less Over 4 cubic meters Minimum \$35.28 \$16.10 per 4 cubic meters or part thereof

Bulk water sales are permitted from the Town's water treatment plant at a rate of \$39.05 per 4 cubic meters or \$9.76 per cubic meter.

2024 MONTHLY WATER RATES:

4 cubic meters or less Over 4 cubic meters Minimum \$36.34 \$16.58 per 4 cubic meters or part thereof

Bulk water sales are permitted from the Town's water treatment plant at a rate of \$40.22 per 4 cubic meters or \$10.06 per cubic meter.
